

SUBIC CLARK ALLIANCE FOR DEVELOPMENT
RESOLUTION NO. 2
Series of 2019

WHEREAS, since its creation, the Authority of the Freeport Area of Bataan (AFAB), has been benchmarking with the SCAD to enable it to adopt similar policies adopted in Subic and Clark;

WHEREAS, in all coordination, planning and harmonization efforts of the SCAD, AFAB has been considered a silent member of SCAD and a partner in all its activities, missions and efforts to develop and promote the SCAD corridor into a world class logistics and economic corridor;

WHEREAS, the AFAB has informally signified a willingness to become part of SCAD however, Executive Order No. 504 (s. 2006) provides an enumeration of the agencies that shall compose the SCAD;

WHEREAS, notwithstanding the exclusive enumeration of EO 504 (s. 2006), Section 3 (c) of EO 504-A (s. 2008) mandates the Office of the SCAD Chairman: "To obtain the required participation, support and assistance of all relevant government agencies and entities as well as concerned local government units in the formulation of the development as well as the implementation of the key components of the said program";

WHEREAS, AFAB is recognized as a substantial economic contributor to the SCAD corridor and a long time strategic partner of SCAD;

WHEREAS, in order for AFAB to participate fully in all deliberations, planning and agreements, an agreement may be forged between the SCAD and AFAB;

WHEREAS, on motion duly seconded, the SCAD Chairman is authorized to execute a Memorandum of Agreement with the AFAB Chairman upon such terms as are acceptable to the parties facilitated by the SCAD Chairman's office;

NOW THEREFORE, RESOLVED as it hereby RESOLVED:

To grant authority to the SCAD Chairman to sign and execute a Memorandum of Agreement between the Subic Clark Alliance for Development (SCAD) and the Authority of the Freeport Area of Bataan (AFAB) in pursuance of the mandates of the SCAD, and to perform such other actions in furtherance of the authority granted herein.


